- **a.** New club and submitted documentation. Approve now or wait till AGM. Want to play in BUCS. Teams get entered April. Club before April then fine. Could enter before official club but need to be voted in.
- **b.** How do we pay for BUCS league fees. Do we pay their entry fees or do we take it from their funding. We pay minimum but if they want more then they pay for more people. Difference from league play payment to separate events payment for clubs such as boat club or tri.
- **c.** Basketball has sent proposal but need to send why they need to be funded. Need to have a sit down to tell them what they need for funding.

6. OpenPlay App – RH

a. On behalf of president of TRI. Proposed looking at app rewarding users when they do physical activity that they can get rewards for. Cost = £10000 annual subscription + VAT. Basically Tesco Club Card + Strava. Need also to get uni approval.

MJ – How many kings students use this app. Can be found out. Is it even worth it JR – Do they know if this is the cheapest route. If they are all the same price isn't there something we could do similar within the RVC?

GJ – anything that costs this much needs a business case to be made. How much interest? Cost/Benefit analysis. Request money from college if there is interest? SU doesn't have a spare £10k to cover the cost. Needs a formal proposal from interested parties to the SU.

7. SU Response to MP Cost of Living Crisis -RH

- **a.** Circulated to all council. Government survey. Has been discussed at trustee board.
- **b.** CAW What is the response? Survey and they want SU's to fill in. Going to be brought to parliament. Evidence from different student unions.

Q3 – more money into fund for hardship. Looking to making one for international students. Digital Support Fund. 5 ways to be well. Allocation upfront for BVetMed4 rotations. Support fund. SU Emergency loan, food handouts, subsidizing events. Transport via minibuses.

Q? (affect on student) – Hockey, coaches, pitch fees, insurance, travel, buying things. Christmas Ball – all prices rising. Increase sub prices. Ability to put on events and affecting student engagement.

- **c.** Q? (Government Support) cant answer? Nothing directly to the student union.. No
- **d.** Q? (how have services changed due to cost of living) cost of café has gone up for students.

- e. Q? (Further comments) student loan not increasing as much as stipend especially postgraduates.

 - **a.** Elections have started. Entertainment officer no longer an officer role but now a staff member. Needs to be removed from the byelaws. Copy of byelaws been sent around to attendees.

- **b.** Correction paid staff position. Not officer position.
- **c.** International apply to position they are only allowed to work 20 hours a week. Probably wouldn't go over in a month. Would have to clarify with HR if it comes to it.

9. AOB

a. Food in restaurants. – lack of vegan options and other dietary requirements in restaurants. Whats listed isn't whats always being served. Not always another option other than jacket potato and beans.

- Raised by JR to Rachel. New chef starting that's keen on doing vegetarian items. Also changing vending machines (Hawkshead) but unsure about Camden Halal options – rare (once, twice a week). From experience, HH meat is Halal, Camden is not. Previous CSF topic to be raised again at CSF. If they are using, they should advertise it more.

- **b.** University stance of Halal meat on pre stun slaughter? Ethically controversial.
- **c.** Trustee point. Paid officer role. Not stated in byelaws. Need to find a way to stipulate and correct this.

PT to suggest under page 22. Standing for an election. Add only run for one role total.

OB – is there anything against nominated twice. Nothing. Have to apply self though.
